1 Introduction

Endress+Hauser would like to have the articles purchased from you packaged in materials which can be used in the internal production process. Chapter 3 shows a list of containers, load carriers and filling materials released by us.





2 Packaging design

Packaging is subsequently defined for individual material numbers. Normally, we will approach you with a list of packaging instructions consisting of the material number, the container and the quantity per container. You will check the feasibility and provide feedback by return. We will also be pleased to assume your improvement proposals in relation to optimum container filling.





2.1 Procedure

- 1. Endress+Hauser creates Packing instructions for material delivered by you and determines which containers are to be respectively used, based on the requirements and handling at our production line.
- 2. After our purchaser has handed the Packing instruction to you, please check the feasibility, the optimum filling quantity of the containers and the protection of the packed articles during transport. Indicate any changes in our list. After you have checked the list with the packaging instructions, please return the same to your contact at the purchasing department of Endress+Hauser.
- 3. If you have indicated any proposals for change the packing instruction, we will discuss them internally and agree a changeover date for the new packaging arrangement with you. We enter the agreed packaging instructions in our ERP system on the changeover date. You will then receive the agreed packaging information on each purchase order.



2.2 General conditions

Transport protection:

The parts must be protected against mechanical, chemical and environmental impact. If the goods do not concern bulk material, the parts are to be protected within the package in such a way that they do not damage each other.

Bulk material:

If possible, bulk material is to be packed in manageable quantities in plastic bags. Several plastic bags are packed in a carton of the Endress+Hauser packaging catalogue. The definition of parts as bulk material is agreed with you by us.

Permitted weights:

Pallets: max. 700kg Half-pallets: max. 488kg Containers: max. 15kg

Permitted pallet height:


Pallets: 1200mm (incl. pallet) Half-pallets: 950mm (incl. pallet)

Capacity usage:

The containers are to be filled to capacity to save transport and storage volume.

Mixed delivery:

Mixed delivery in containers is to be avoided on principle. Should this be inevitable, the mixed container must be clearly marked as such.

3.3 Packaging aids

Permitted and unpermitted packing aids

	Desired	Undesired
Container	Nonreturnable cartons corresponding to EuroFix dimensions. Possibly returnable containers (as agreed with Endress+Hauser)	Containers protruding beyond the load carrier. Containers not corresponding to the EuroFix standard.
Pallets	Euro exchange pallets, half- pallets (corresponding to euro- pallet quality)	One-way pallets
Foils/bags	PE foils, PET	
Straps	PP, PET	PVC, steel straps, polyamide traps, polyester straps
Filling material	Cardboard, paper, PE air cushioning	Wood shavings, glass wool, packaging chips, styrofoam

4 Labeling

4.1 Package marking

Every packing unit must be marked at least as follows:

Material: (E+H article number)

Quantity: (actual quantity)

Additionally, in case of goods requiring a certificate:

E+H charge: (5 digit E+H identification number(s)/ charge number(s))

Example:

On containers, the marking must be shown on the front side. It is important, that the marking is printed in German and English, since the goods are also used in our foreign operations. If possible, all data should also be printed as a barcode (Code 39 or 128).

4.2 Kanban cards

Kanban cards must be attached on the outside of packages and readily readable. It must be possible to scan kanbans delivered on pallets without any repacking.

4.3 Delivery notes

To facilitate the receipt of shipments, the E+H order number is to be printed in plain text and as a barcode on every delivery note.



5 Rules

The subsequently described rules concerning the firmly defined packaging instructions are to be observed without fail:

Short/over delivery tolerance

A short/over delivery tolerance is not granted in kanban and contract parts, since the supplier is supposed to produce on stock in its own store and thus does not have to deliver the exactly produced quantity. At the end of the contract term, a one-time shipment of a residual quantity may be effected. Any packaging unit not completely filled at that time, must be clearly marked as such! In case of individual orders, the quantities ordered by Endress+Hauser are to be observed. According to legal provisions, a short/over delivery tolerance of 10% is granted depending on the production process.

Change of charge

If the residual quantity of the previous charge does not result in a complete packaging unit, the package is to be completed with the new charge. Different charges must be stated, including quantity and E+H charge number, on the delivery note and in the marking of the package.

Partial deliveries

Partial quantities must be delivered in full packaging units. The delivery of partial quantities has to be agreed with the operative purchaser of Endress+Hauser.

Example:

Purchase order: 500 pieces in container B5 à 100 pieces

Partial production: 283 pieces

Partial delivery: 200 pieces in 2 containers à 100 pieces.



6 Procurement of packaging materials

You are free to procure the agreed packaging materials wherever you wish to do so. You may contact our supplier of packaging materials, Prodinger OHG in Germany or Prodinger Verpackung AG in Switzerland and obtain the standard packaging materials at Endress+Hauser terms.

As a supplier, you are responsible that the required packaging materials are available on time. If goods are delivered in other than the agreed packaging materials, Endress+Hauser reserves the right of charging additional costs incurred for repacking to the supplier. In addition, non-compliance with the agreed packaging instructions will have a negative effect on the supplier assessment.
